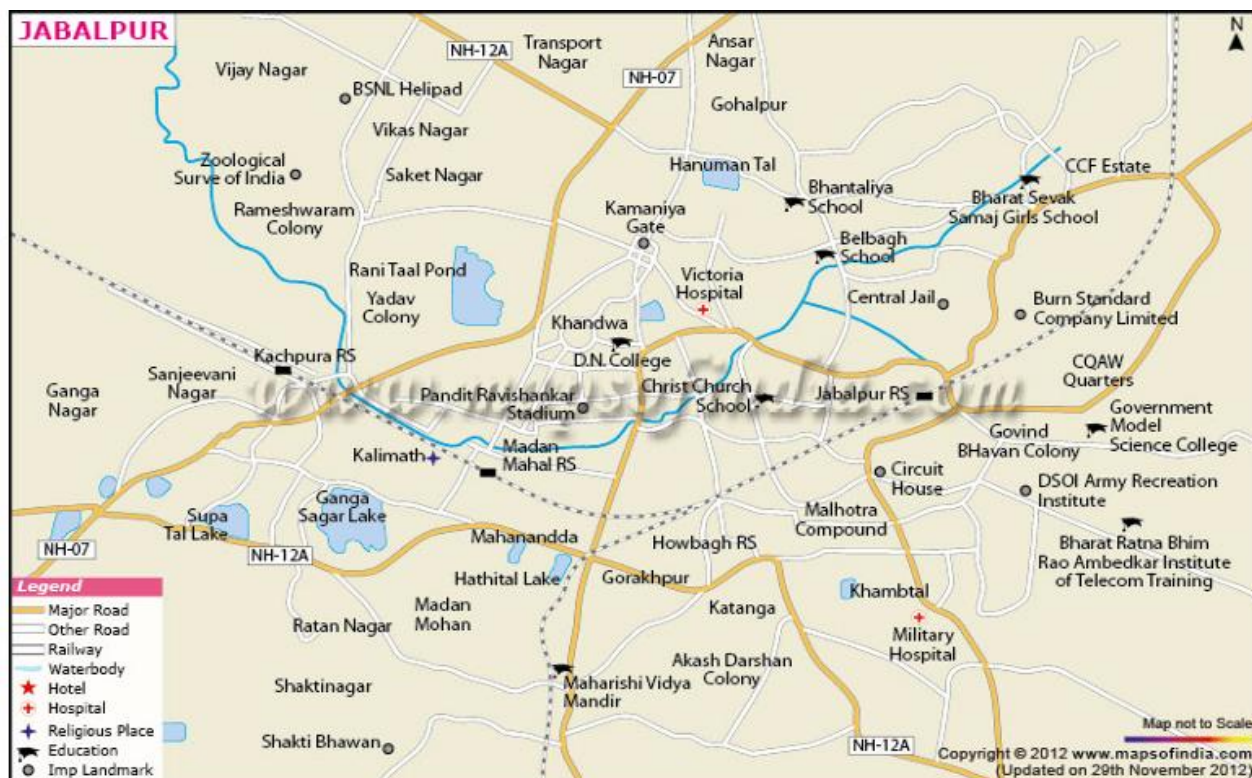
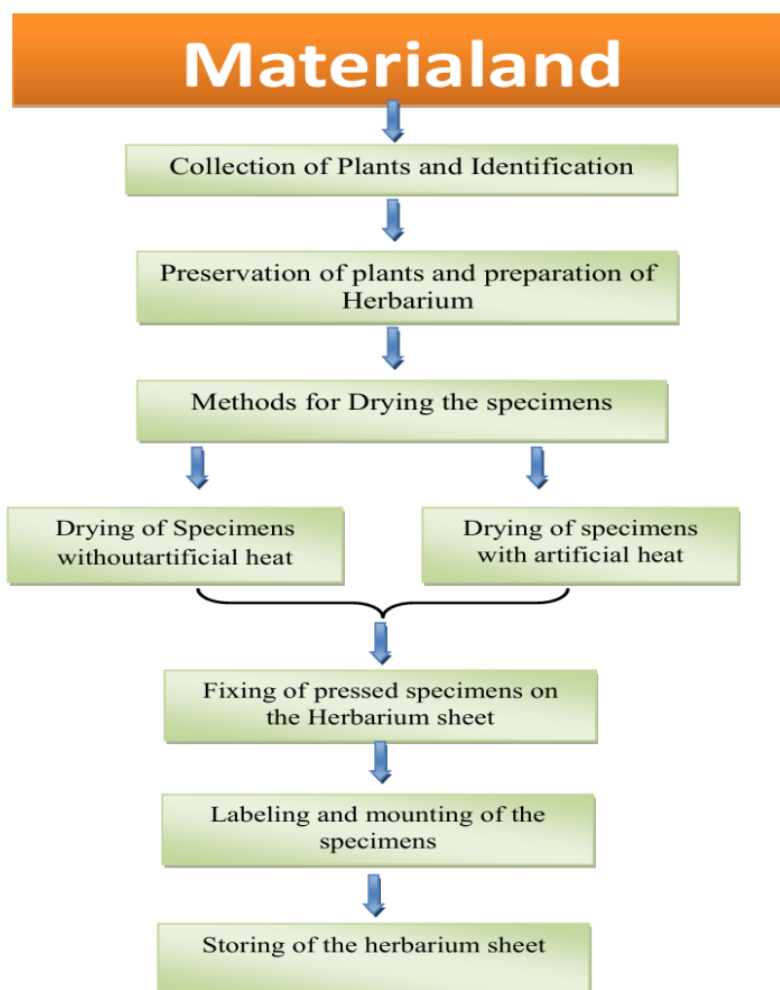
skincare to henna for haircolouring Indian womens have long embraced herbal remedies.
